

## **Rhywogaethau Goresgynol Estron y Môr a Physgodfeydd Nodyn Gwybodaeth i Randdeiliaid**

Ar 1 Ionawr 2015 cyflwynodd y Comisiwn Ewropeaidd Reoliad newydd ar rywogaethau goresgynol estron (a elwir hefyd yn rhywogaeth estron goresgynol), Rheoliad 1143/2014[1]. Mae'r Rheoliad yn ceisio mynd i'r afael â'r broblem rhywogaethau goresgynol estron (IAS) er mwyn diogelu bioamrywiaeth frodorol, gwasanaethau'r ecosystem ac er mwyn lleihau a lleddfu'r effaith y mae'r rhywogaethau hyn yn ei gael ar iechyd pobl a gweithgarwch economaidd.

Yn unol â'r meini prawf y cytunodd pob Aelod-wladwriaeth arnynt yn dilyn asesiadau risg gwyddonol, mae'r rhestr gyntaf sy'n cynnwys 37 o rywogaethau â blaenoriaeth yr Undeb Ewropeaidd[2] wedi cael ei chyhoeddi. Daeth y rhestr i rym ar 3 Awst 2016.

Mae'r rhestr yn cynnwys un rhywogaeth forol, y cranc manegog Tsieineaidd a nifer o rywogaethau dŵr croyw, gan gynnwys y Llyfrothen Uwchsafn a Chimwch Afon America (ac eraill megis y cimwch afon brith, cimwch coch y gors, y cimwch afon rhesog a chimwch afon y gogledd).

Mae'r rhywogaethau a restrir yn ddarostyngedig i nifer o gyfyngiadau a mesurau ar draws yr Undeb Ewropeaidd. Mae'r rhain yn cynnwys ymyrraeth sy'n atal cyflwyno ac sy'n rheoli lledaeniad y rhywogaethau a restrir.

## **Marine and Fisheries Invasive Alien Species**

### **Stakeholder Information Note**

On 1st January 2015 the European Commission introduced a new Regulation on invasive alien species (also known as invasive non-native species), Regulation 1143/2014. The Regulation seeks to address the problem of Invasive Alien Species (IAS) to protect native biodiversity, ecosystem services and to minimise and mitigate the impacts these species can have on human health and economic activity.

In line with criteria agreed with all Member States and following scientific risk assessments, the first list of 37 priority species of European Union2 concern has been published. This list came into force on 3rd August 2016.

The list includes one marine species, the Chinese Mitten Crab and a number of freshwater species, including Topmouth Gudgeon and Signal Crayfish (plus others such as Marbled, Red Swamp, Spiny-cheek and Virile crayfish).

Species listed are subject to a number of restrictions and measures across the European Union. These include interventions that prevent the introduction and manage the spread of species listed.
